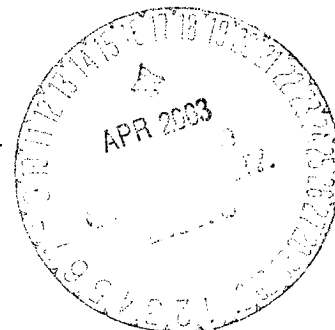

It is intended to add the Menefee interval and recompleate the subject well in the Chacra as follows:

It is intended to isolate the existing Mesaverde perforations and perforate and fracture treat the Menefee interval. The entire Mesaverde interval will then be isolated and the Chacra interval perforated and fracture treated. Both the Mesaverde and the Chacra will be cleaned up and stabilized. Production tubing will be landed. The well will then be commingled. Commingled order DHC-1098az has been obtained. A Chacra C-102 plat is attached.
