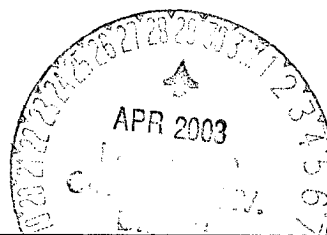
On 3/19/2003 the cement job on the intermediate casing of subject well yielded no returns during job. A temperature survey was run and TOC was found at 2310'.

As per phone conversation with Jim Lovato, shot squeeze holes at 845' and squeezed with 200 sx (36.7 bbls) of class "B" cement. Circulated 8 bbls cement to surface during squeeze operation.
