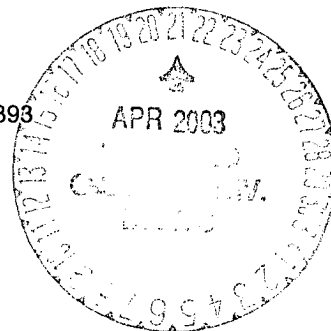

Bumped plug @ 0945 hrs w/393 psi. Circ. 15 bbls good cement to surface. WOC. NU ram and Annular stack. PT casing, rams and manifold to 600 psi for 30 minutes. Good test.
