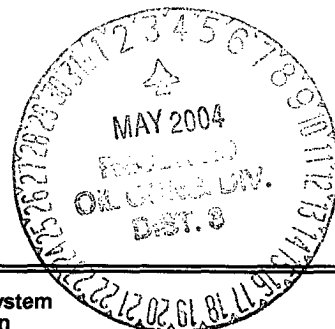

In preparing this well for plugging, it was discovered that the well had 200 psi on it. The casing was opened and the well unloaded. We request that plugging be postponed at this time. By 5/20/04 we will install a pump jack to test the potential for gas production. If the well is not capable of production, it will be plugged as now permitted.
