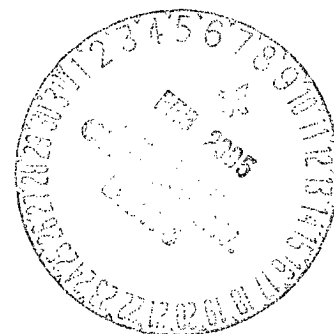

The well has now been placed on our rig schedule and we anticipate the plugging operation to be completed by the end of the month.
