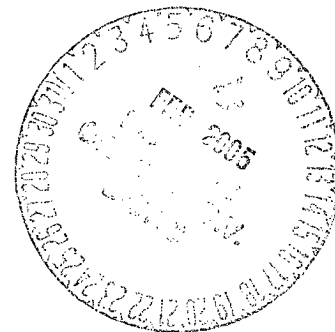

Based on this review uphole potential does exist in the wellbore, therefore, procedure to recompleat is being prepared and will be submitted to your office for approval within the next two weeks.
