Black Hills Gas Resources, Inc. plugged and abandoned the above well on October 29, 2004. Plugging procedures as follows:

Pump 37 sx of Class B Neat/ 15.6 PPG cement and displace w/19.5 bbls of water. Spot balanced plug over PC/Kirtland from 3813-3474'. Pump 80 sx of Class B neat/ 15.6 ppg cement and displace w/17.4 bbls of water. TOC @3166'. Pump 143 sx of Class B neat/ 15.6 ppg cement and displace w/12 bbls of water. TOC @ 2578'. Pump 75 sx of cement and displace w/12.5 bbls of water. Balance plug over Nacimiento top from 2362-2215'. Pump 75 sx of cement and displace w/8.5 bbls of water. Balance plug over San Jose top from 1665-1505'. Pump 65 sx of cement and pump down casing, up braiden head until cement to surface. Cut off casing 5' below ground level and weld on plate. RDMO. Plugging procedures witnessed by Bryce Hammond with the Jicarilla Oil & Gas.
