When drilling 100' PC sump in subject well, a significant gas show was seen in PC. After discussion with BLM it was decided to abandon sump. During cavitation operations, sump was filled with cuttings from above. A Bentonite plug was mixed and spotted across top of PC from 3570' to 3542'. After liner was run in hole the new PBTD is 3542'.
