RIH w/underreamer & underreamed 6-1/4" hole to 9-1/2" from 3017' - 3551'. Circ. hole. Ran open hole logs. Started surging well naturally to C/O fill. Then surged w/air & mist. Surged for approx. 26 days. 1/18/05 TIH & C/O to TD. TOH. RIH w/16 jts of 5-1/2" 15.5# K-55 LT&C perforated liner and set liner @ 3551' w/top of liner @ 2975 (42' overlap). Perforations @ 3462' - 3441', 3379' - 3292', 3250' - 3185', 3121'-3099'. RIH w/mill & milled perf plugs. Circ hole. RIH w/2-3/8", 4.7#, J-55 8rd EUE tbg (96 jts) and set @ 3490'. ND BOP, NU WH. RU Rod equipment. Load tbg & test to 500 psi. Spaced out rods and hang Beam Stroke pumped. RD & released rig 1/20/05. Turned over to production to first deliver.
