Drilled 6 1/4" hole to 3,710' on 11/09/04, set 81 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,710'. Cemented lead w/250 sx (65 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. Circulated 15 bbls of cement to surface. Landed 2 3/8" production tubing at 3,321'.
