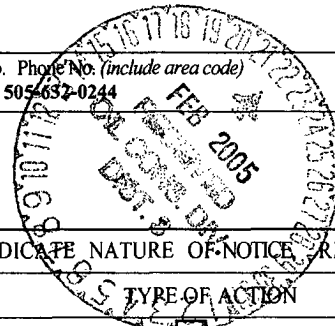

Drilled 12 1/4" hole to 310' on 7/18/04, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 300'. Cemented w/175 sx (36 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 10 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,535' on 7/21/04, set 82 jts of 7", J-55 LT&C, 23# casing at 3,530'. Cemented lead w/500 sx (129 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (18 bbls) STD, 4/10% Halad 344. Circulated 35 bbls of cement to surface. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 7,925' on 07/24/04, set 186 jts 4 1/2", J-55, LT&C, 11.6# casing at 7,919'. Cemented lead w/235 sx (66 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/450 sx (116 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface, TOC at 1,100'. Landed 2 3/8" production tubing at 7,859'.
