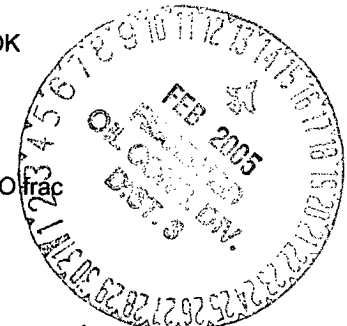

- 6) TIH w/tbg, OPMA, SN, pmp, rods. Land tbg @ approx 6680' & SN @ approx 6650'.
