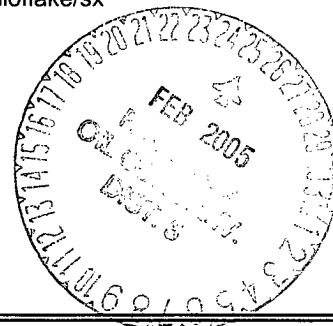

(253 cu ft total slurry). Circulate 8 bbls contaminated cement.
