Drilled 12 1/4" hole to 309' on 09/21/04, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 299'. Cemented w/175 sx (36 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Trace cement returns to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,765' on 09/27/04, set 86 jts of 7", J-55 LT&C, 23# casing at 3,756'. Cemented lead w/425 sx (111 bbls) 50/50 POZ w/2% Gel, 2/10% Versaset, 1/10% Diacel LWL, and tail w/75 sx (20 bbls) STD 50/50 POZ w/2% Gel, 2/10% Versaset & 1/10% Diacel. Circulated 1 bbls of cement to pit. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 8,179' on 10/14/04, set 180 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,177'. Cemented lead w/250 sx (64 bbls) 50/50 POZ w/2% Gel, 2/10% Versaset, 1/10% Diacel LWL and tail w/450 sx (118 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface. Landed 2 3/8" production tubing at 8,081'.
