02/19-21/05 Flow back frac and TOH laying down 3-1/2" workstring. Set composite frac plug @ 1810'.

02/22/05 Refrac Upper Fruitland Coal from 1726-86' with 76,568 gals 70Q Linear foam fluid, 5000# 40/70 sand and 82,200# 20/40 Brady sand.

02/23-28/05 Flow back frac, clean out to PBTD, landed 2-3/8" tubing @ 1750'. Returned well to production.
