Circ & surged well w/ air mist & naturally for 7 days. Then drilled 6-1/4" hole from 3087' to 3353' TD. TD reached 2/10/05. Natural & air surged. C/O to TD. 2/10/05 RIH w/ 5 1/2" 15.5# K-55 LT&C casing and set liner @ 3353' w/ TOL @ 3006' (11' overlap unto 7" shoe). Liner is a pre-perf'd liner @ 4 hpf.
