DETAILS OF WORK

Well has been drilled to a total depth of 4345 feet with rotary tools. The 9-5/8" casing was landed at 222 feet with 180 sacks of cement. Four drill stem tests were run over the Fruitland and Pictured Cliffs formations with no commercial show of oil or gas. DST #1 (3830 to 4050 feet), DST #2 (4053 to 4121 feet), DST #3 (4121 to 4221 feet), and DST #4 (4215 to 4315 feet).

It is now proposed to drill well to an approximate depth of 6900 feet to test the Mesaverde formation.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
