1st stage lead: +/- Premium Lite HS w/additives mixed @ 12.5 ppg & 2.01 cuft followed by 150 sx Type III w/additives mixed @ 14.2 ppg & 1.54 cuft. Cement volume to be adjusted based on caliper log plus 40%. Plan to circ cmt to the DV tool (+/- 4000').

2nd stage lead: +/- 600 sx Type III w/8% gel & additives mixed @ 11.9 ppg & 2.54 cuft followed by 100 sx Type III neat mixed @ 14.5 ppg & 1.39 cuft. Cement volume to be adjusted based on caliper log plus 40%. Plan to circ cmt to surf.
