On 12/17/2004, set 12 jts of 5 1/2", J-55, 15.5#, LT&C Liner was run to 3,195' with 0 sx of cement. Top of liner hanger is at 2,647'. Perforations are from 2,834' - 3,130', 4 SPF, 0.49", 360 holes, 120 degree phasing. On 12/18/2004 ran back in hole with 99 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,163', return well to sales on 12/20/2004.
