Proposed perforations are: MV - 2298' - 4878' ; DK - 6520' - 6885' These perforations are in TVD.

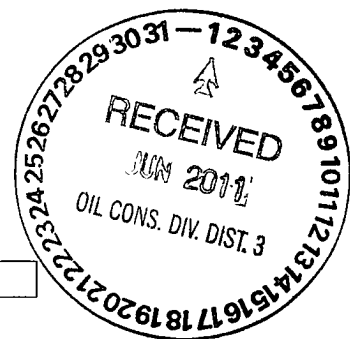
