6-16-2011- RIH with WS to 1409', mix and pump 32 sks @ 15.1 ppg. LD WS.

6-17-2011-RIH with WS, tag bottom plug at 1160.76'. LD WS. Mix and pump 50 sks @15.2 ppg for outside plug. At 30 sks, cement came out and around surface casing. Shutdown pump. Consult BLM.

6-20-2011- RIH with WS to 652.70'. Mixed and pumped 65 sks @15.1 ppg for top plug.

6-21-2011- Tagged cement @30'. Mix and pumped 7 sks @ 15.1 ppg. Cut off casing. Place P&A marker.
