Pursuant to 43 CFR 3163 1(a)(2)&(c) an assessment of \$250 00 is imposed per violation not to exceed \$500 00 per lease for a total of \$750 00 for failure to comply with a written order. You will be billed for the amount of \$750 00 by our office

You are hereby given until March 10, 2009 to come into full compliance with the written order of January 6, 2009. If you fail to come into full compliance within this time period, you may be liable for civil penalties for this minor violation pursuant to 43 CFR 3163.2

Under provisions of 43 CFR 3165 3, you may request an Administrative Review, before the State Director either with or without oral presentation, of the proposed civil penalties described above. Such a request, including all supporting documentation, shall be filed in writing with the State Director, Bureau of Land Management (NM-93000), P. O. Box 27115, Santa Fe, New Mexico 87502-0115 within 20 business days of the date this notice was received or considered to have been received. Such request shall not result in a suspension of the order unless the reviewing official so determines. Procedures governing appeals from instructions, orders or decisions are contained in 43 CFR 3165 4 and 43 CFR 4 400 et seq.
