The BHL listed in Box 4 of the 3150-5 form submitted on the 13th was incorrect. The correct BHL footage should have been 1117' FSL, 330' FWL Sec 36 T23N, R8W, as shown above. Please make note of this correction. The Directional Drilling Plan, 10-Point Drilling Plan and Wellbore Diagram associated with the November 13th sundry submittal are not being re-submitted because the correct BHL was referenced on all of those documents.
