Burlington Resources is requesting to modify the below-grade tank permit for the HANLEY 3 to correct an administrative error.

Burlington Resources found that the HANLEY 3 shares a Below Grade Tank with the W M HANLEY 1F and requests to modify the permit for the twinned location and the latitude and longitude of the existing permit.
