Burlington Resources is requesting to modify the below-grade tank permit for the SAN JUAN 28-7 UNIT 243P to correct an administrative error.

Burlington Resources found that the SAN JUAN 28-7 UNIT 243P shares a Below Grade Tank with the SAN JUAN 28-7 UNIT 105 and requests to modify the permit for the twinned location and the latitude and longitude of the existing permit.
