- Pressure test casing to 600 psi.
- Spot Plug I above retainer @ 1427'-2058' w/52 sks (61 cu ft) Class G neat cement (15.6#/gal, 1.15 cu ft/sk) - Fruitland-Kirtland-Ojo Alamo, Plug I: 1427'-2058'.
- Spot Plug II below surface casing shoe @ 170' w/17 sks (20 cu ft) Class G cement w/2% CaCl2 (15.6#/gal, 1.15 cu ft/sk) - Nacimiento-San Jose-Surface, Plug II: 0-170'.
- Tag TOC at surface. Fill cement in case needed. Cut wellhead.
- Install dry hole marker. Cut anchors. Clean location.




Current wellbore Schematic
