Cement with 50% excess, pump 10 bbls FW spacer, 31 bbls (109 sx) Type I-II cement with 20% Fly Ash at 14.5 ppg, 1.61 yield. Drop plug, displace with 26 bbls FW. Bump plug at 250 psi. 8 bbls good cement to surface. Check floats. Floats held. RDMO.
