Proposed perforations are: MV - 3552' - 6135' ; DK - 7607' - 7870' These perforations are in TVD.

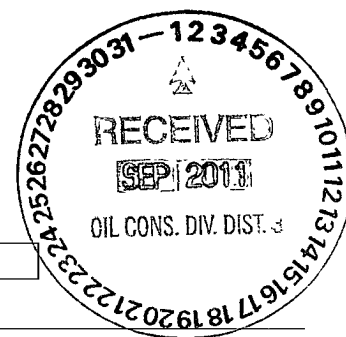
As referenced in Order # R- 10695 interest owners were not re-notified.
