9/7/11 Picked up 4.50" packer and TIH. Set packer at 5673'. Pressure tested casing from 5673' to surface to 1000# for 30 minutes - good test. Unset packer and TOOH with 4.50" packer.

According to Onshore Order #2 III.B.1.h production casing must be pressure tested to a minimum of 1500 psi for 30 minutes. Approval is needed to pressure test under 1500 psi. In the future, request the approval prior to the pressure test.
