Proposed perforations are: MV - 2749' - 5226' ; DK - 6917' - 7194' These perforations are in TVD.

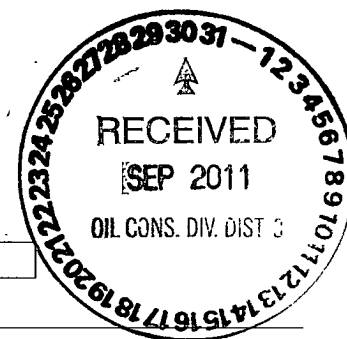
