CLOSURE:

1. All liquids and cuttings were hauled off by Pace/Scat Hot Wash (505-327-1958) to the disposal facility, TNT Environmental, Permit #NM-001-0008.
2. The metal tanks were hauled back to the yard.
3. The closed loop equipment was inspected daily by the workover rig crew and any necessary maintenance performed.
4. There were no leaks or spills in the system.
5. The closed loop impacted no additional area on the well pad, resulting in no additional reclamation being necessary.
