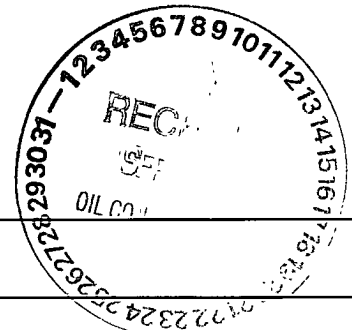
The Rosa 32C MV/DK was inactive for a period greater than 90 days, the well resumed production on October 8, 2010.
