9/9/11 Drill 8.75" hole to 3675' and cement plug #1 from 3675' up to approximately 3200' MD. Pumped 250 sks. of Class G cement, .2% Halad-344, .2% CFR-3. (280 cf). TOH up to 2750' and circulate. TOH up to 1200'. WOC. TIH, tag cement at 2840'. Cement plug #2 with 260 sks of Class G cement, 2% KCL (275 cf). TOOH to 1600' and circulate. No cement to surface. WOC. TIH, tag TOC @ 1900'. Drill cement from 1900'-2712'. Circulate hole clean.

9/19/11 Drill 8.75" hole to 3760'. Run 90 jts of 7" 23# J-55 LT&C casing, set at 3759'. Cement with 500 sks. of 65/35 POZ, 1/8#/sk. poly-e-flake, 2% CACL, 10#/sk gilsonite (955 cf). Tail with 150 Class G cement, 1/8#/sk. poly-e-flake (172 cf). Plug down at 3:30 pm on 9/25/11. Circulated 70 bbls of cement to surface. WOC. Pressure test BOP 250# low - 15 minutes and 2000# high - 15 minutes - ok. Pressure test 7" casing at 1500# for 30 minutes - ok.

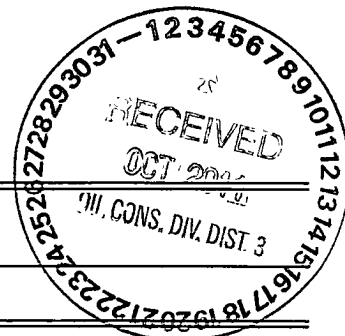
