Bump plug at 11:15 am on 9/28/11. Float held. Did not circulate to surface. WOC. Ran Temperature Survey - TOC @ 15'. Cement with 120 sks. Class G neat cement for top off (144 cf). Brought cement to surface. WOC. Test BOP 250# low, 15 minutes and 2000# high, 15 minutes - ok. Test casing at 750# for 30 minutes - ok.
