10/8/11 Spud well at 10:00 am on 10/8/11. Drill 12.25" hole to 178'. Run 4 jts of 8.625" 24# J-55 casing, set at 174'. Cement with 140 sks of Type V cement, 2% CaCl2, 1/4#/sk poly-e-flake (168 cf). Plug down at 5:00 pm on 10/8/11. Circulated 13 bbls of cement to surface. WOC. Test BOP 250# low, 5 minutes -ok and 2000# high, 10 minutes - ok. Pressure test casing to 750# for 30 minutes - ok. ✓
