10/10/11 Cement 1st stage with 180 sks of 50/50 Poz, 2.5 ppb coal seal, 1/8#/sk poly-e-flake, .6% Halad R-9, .2% CFR-3 (232 cf). Plug down at 9:30 am on 10/9/11. Did not circulate cement to surface. Cement 2nd stage with 280 sks of 50/50 Poz, 2.5 ppb coal seal, 1/8#/sk poly-e-flake, .6% Halad R-9, .2% CFR-3 (361 cf). Did not circulate cement to surface. WOC. Run temperature survey. TOC is at 175'. RMD on 10/11/11.
