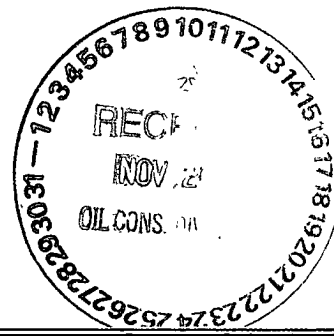

XTO Energy Inc pressure tested 8-5/8" csg on 10/7/11 to 800 psig f/30 min. Tested Ok. BLM on location to observe pressure test.

Drilled a 7-7/8" hole to 7685' (TD) on 10/16/11 10/19 thru 10/20/11 - Ran 5-1/2", 17#, S-90, LT&C casing to 7,684'. Ppd 250 sx Poz Premium cmt (13.5 ppg & 1.32 cuft/sx yield). Bumped plug @ 550 psig. Increased psig to 928. Tstd OK. Dropped bomb & attempted to shift DV tool open. Pressured up to 1200 psig. Increased to 2650 psig DV tool failed. Unable to circulate.

Released rig @ 06:00 hrs on 10/20/11 *AV*

Will remediate cement & production casing will be tested upon completion.
