It is intended to remove the packer of the dual string in the subject well to produce the Blanco Pictured Cliffs (pool 72359) and the Blanco Mesaverde (pool 72319). The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Proposed perforations are: PC - 3168' - 3200' ; MV - 5410' - 5524' These perforations are in TVD.
