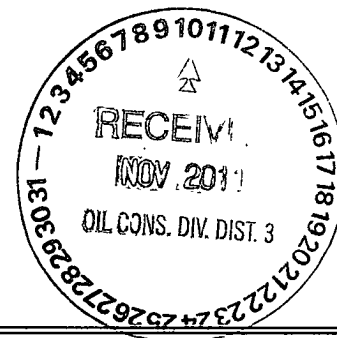

NU BOP. Pressure test blind rams & csg to 800 psi for 30 mins, held ok. Pressure test pipe rams to 2000 psi for 10 mins, held ok; 250 psi for 5 mins, held ok. Pressure test choke manifold, kill line & Kelly valve to 2000 psi for 10 mins, held ok; 250 psi for 5 mins, held ok.
