During the last several months, various surface equipment repairs have had to be made. In early October, 2011, the downhole pump was pulled and changed out. On October 15, 2011, this well produced 10 Bo/d and during the last 14 days, this well has produced 41 barrels of oil and is now producing approximately 3 barrels of oil per day.
