Tst inside valve 20 psi/5 mins, 3000 psi high/10 mins. OK. Test Blne rams 250 psi 5 mins, 3000 psi high/10 mins. OK. Test pipe rams 250 psi low/5 mins, 3000 psi high/10 mins. Hydrill 1500 psi 15 min. Test floor valve and upperkelly valve 250 low/5 mins, 3000 high/10 mins.
