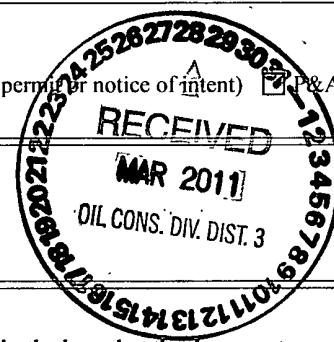

All liquids were hauled to a company disposal well and cuttings were hauled off by Riley Industrial (505-327-4947) to the disposal facility, Envirotech, Permit #NM-01-0011. The flow tank was then hauled back to the yard.

The closed loop equipment was inspected daily by the workover rig crew and any necessary maintenance performed. There were no leaks or spills in the system.
