2/18/2005 NU. Test BOP. PT blind and pipe rams to 250 low and 2000 psi high, OK. Rig up flow line. Drill 7-7/8" hole to 700'. Displace hole with water/poly. POH/RIH to change drig assy. 2/20/2005 Wash 30' to btm. Drill 7-7/8" hole to 1150', TD. Short trip. RIH w/wireline and run wireline logs. RIH w/27 jts 5-1/2" csg to 1135', with 21' shoe track. Cement csg w/80 sx Type 3, 12# ppg, 2.55 yield, followed by 70 sx Type 3 tail at 13 ppg, 2.0 yield, 15 bbls back to pit.
