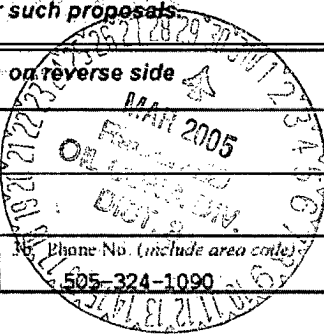

Plug #2: 225 sx Type III cmt w/3% CC & 1/4 PPS celloflake (15.2 ppg, 1.28 cuft/sx) fr/1,778' to 1,035' (tgd top of plug @ 1,035').

Plug #3: 300 sx Type III cmt w/3% CC & 1/4 PPS celloflake (15.2 ppg, 1.28 cuft/sx) fr/846' to 390' (tgd top of plug @ 390').

Plug #4: 145 sx Class "B" cmt w/3% CC & 1/4 PPS celloflake (15.6 ppg, 1.18 cuft/sx) fr/390' to surf. Circ 10 bbls cmt to surf.

BLM representatives Cliff Ollom & John Coy were on location during plugging operations. Released drlg rig & equip. Drlg operations will resume in July 2005.
