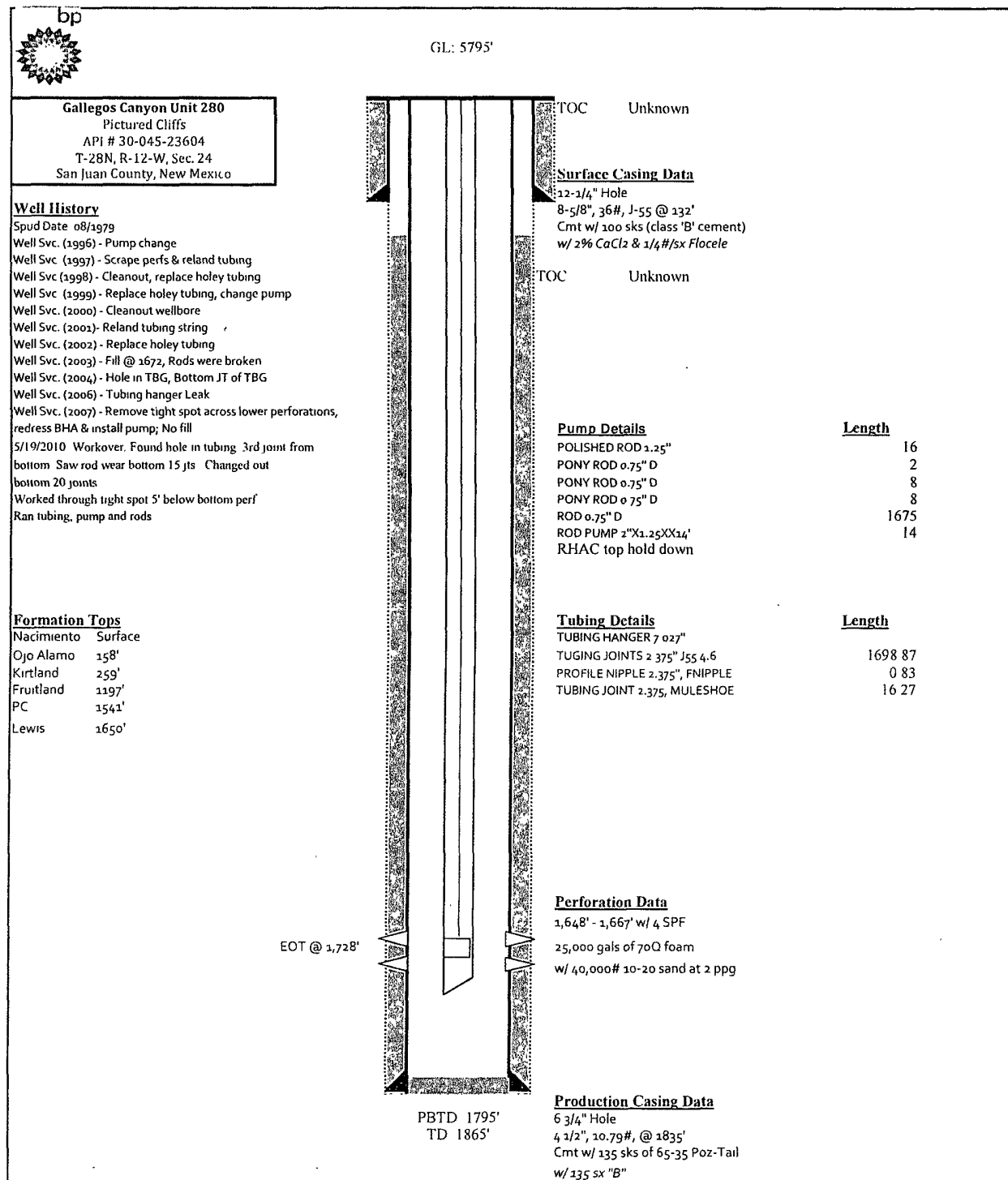
Basic Job Procedure:

1. Kill well. POH rod and 2-3/8" tbg.
2. RIH with scrapper to ~ 1,600 ft
3. RIH and set 4.5" CIBP at ~1,600 ft
4. PT casing to 500 psi. RIH with CBL to determine TOC.
5. Pump a balance plug from CIBP to ~ TOC found in the CBL
6. If necessary. Perforate 4.5" casing and circulate cement to surface.
7. Install well marker and identification plate per regulatory requirements. RD MO Location
