**STAGE 3: TO SET PACKER AT 2077', AND PUMP 52 BAGS TO 2077' RELEASE PACKER WITH ON/OFF TOOL;**  
**STAGE 4: FILL 2483' OF CASING WITH WATER TO APPROX. 400' TO THE SURFACE AND CAP WITH A CEMENT PLUG;**  
**SET P&A MARKER - RESTORE SURFACE - PLUGGING & RESTORATION COMPLETED BY 12/31/12**


