

Run in hole w/ drill pipe to 2838', Plugged well w/ cement by pumping 615 sxs class III (1.37 cuft/sx yield, 14.6 ppg) 150 bbls slurry, wait for 4 hrs, tag cmt @ 517', pumped another 164 sxs class III (1.37 cuft/sxs yield, 14.6 ppg), 40 bbls slurry, topped of surface csg w/ 17 sxs class III cement (1.37 cuft/sxs yield, 14.6 ppg) 5 bbls slurry at surface, welded on dry hole marker, total of 796 sxs of cement and wellbore has cement from surface to 2,838'.
