Released and POOH w/both RBPs. 9/22/11 RIH w/4-3/4" mill & tagged @ 3593'. M/O CIBP @ 3595'. Circ. CIBP fell to TOL @ 3612'. M/O CIBP @ 3612', but couldn't get through TOL. 9/26/11 RIH w/smaller bit & D/O CIBP & C/O to PBTD @ 3921'. POOH. Start air unit & unload well to 3920'. Circ. hole. Flow test entire wellbore. POOH. 9/29/11 RIH w/120 jts 2-3/8" J-55 tubing and landed @ 3861' w/F nipple set @ 3830'. ND BOP. 9/29/11 test tubing - OK. RIH w/Pump and rods. Tested tbg. Spaced out pump and rods.
