13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. The following procedure is proposed for the subject well:

- Move in and Rig Up well service unit
- Kill well as necessary with viscous fluid
- Trip out of hole and lay down rods, pump and production tubing
- Remove wellhead
- Secure well with 4 1/2" X 2" swage and ball valve
- Move rig out
- Rig up cementing company to well
 - o Mix 30sx lead cement with 2%CaCl2, 1/4#/sx cellophane, 3#/sx gilsonite to 15.6 ppg followed by 70sx cement with 2%CaCl2 at 4bpm
 - o Do not displace cement
 - o Wash up equipment to water tank with 25# sugar added
- Wait overnight
- If cement is not at surface, tag and top with neat cement as necessary
- Dig out, cut off, install marker, remediate location as indicated in conditions of approval
