It appears that the Bradenhead test on September 15, 2004 was a failure due to the excess pressure on the Bradenhead. When the Bradenhead was blown down there was no apparent communication to production casing or intermediate casing. There was also no apparent communication between the intermediate casing and the production casing. In order to resolve this matter a witnessed retest of this well will be scheduled and following the retest, remediation will be pursued if necessary.
